1. Call to Order

Dillon called the meeting to order at 6:30 p.m.

2. Roll Call

The following board members were present:

Craig Mellon, Wes Spohr and Samantha Dillon. Tawney Fisher and Connie Fleming were absent

The following staff member was present:

Courtney Zollinger, City Clerk and Chadd Posch, Parks and Facility Superintendent.

3. Approval of the July 23, 2020 Meeting Notes

Motion: *Mellon* moved, *Spohr* seconded to approve the minutes. Voted and passed unanimously.

4. Business

a. Pickleball Striping

Posch presented a new quote from Mid-American Courtworks that included striping only of one tennis court into two pickleball courts. The cost to stripe only is \$700.00. Posch explained the original quote included resurfacing the tennis courts and his opinion there is nothing wrong with the courts themselves. Dillon asked what type of striping Mid-American Courtworks would use. Posch reported they would be using an epoxy paint for the striping so it should be quite durable. Posch suggested moving forwarding with striping of one court and see if it gets used. If the courts get used frequently the board could look at putting more money into the courts in the future. The board liked the idea of only spending the \$700 on the courts for now.

Motion: *Mellon* moved, *Spohr* seconded to approve the proposal from Mid-American Courtworks for striping one tennis court into two pickleball courts for \$700. Voted and passed unanimously.

Dillon asked for Posch and Zollinger to keep the board in the loop on the progress of the project.

b. Playground Equipment

Posch stated that the board received several images for playground equipment ideas for the Chisholm Trail Sports Complex during the last meeting. He was hoping that the board would be able to narrow some ideas down so we can try and put together a project to present to Council. Through all the images from Athco Landscape Structures the board narrowed it down to designs 6359, 4317, and 6318. Zollinger and Posch will contact Athco and get pricing for turnkey installation on the sets as well as look into grants that could be available as well for the project.

5. Other Business

Posch stated that at the next meeting he would like to introduce resurfacing the basketball court at City park with Play On All Weather. He asked them to search the product so we could talk about it at the next meeting.

Dillon asked where we were with the park shelters. Zollinger stated we were waiting to hear back from Wayne Berntsen to schedule a meeting to go over plans. She said PEC would like an opportunity to look at the project. Zollinger and Posch said that would be great. Dillon is going to set up a time for Nick Staib with PEC to come meet with Posch and Zollinger
